State Systemic Improvement Plan (SSIP)

The Office of Special Education Programs (OSEP) requires each State Educational Agency (SEA) to develop a State Systemic Improvement Plan (SSIP) as part of the State Performance Plan/Annual Performance Report. Arkansas's multi-year plan outlines strategies to address state capacity for leading change efforts in Local Educational Agencies (LEAs). The Arkansas SSIP is intended to drive innovation in the delivery of services to students, especially students with disabilities in accordance with the Individuals with Disabilities Education Act (IDEA). The Arkansas SSIP highlights the need for a system of support that is aligned with other units within the Arkansas Department of Education to improve the literacy results in grades 3-5 for students with disabilities. The SSIP is aligned with the Arkansas State Personnel Development Grant (SPDG) to support general and special educator collaboration focused on improving tiered systems of support for academics and behavior through the implementation of high-leverage and other evidence-based inclusive practices. The State-identified Measurable Result (SiMR) for Arkansas is the percent of students with disabilities in grades 3-5, from targeted schools, whose value-added score in reading is moderate or high for the same subject and grade level in the state.

The SSIP targeted schools have continued receiving support through the State Personnel Development Grant (SPDG) and through the Inclusive Practices Project. For more information regarding SPDG-supported schools, see the above SPDG section of this report. A new cohort (Cohort 4) of the Inclusive Practices Project was announced via a statewide webinar on March 16, 2023. The timeline for this project is as follows:

Current (Cohort 3) project schools have completed an overview, a needs assessment, a PLC Continuum Survey, and initial principal and teacher efficacy surveys. Follow up principal and teacher efficacy surveys will be collected in April. The SSIP Coordinator and state liaisons have visited with project schools to observe collaborative processes and collect value creation stories regarding the work. The value creation stories will be included on the Inclusive Practices Website and in an Inclusive Practices Toolkit that is being developed to engage stakeholders with information about the All In Initiative. The SSIP Coordinator facilitated a parent/family engagement session on March 16th in collaboration with The Center for Exceptional Families (TCFEF). The focus of this engagement session was to seek feedback regarding the Inclusive Practices Toolkit and supporting resources. Data acquired from this stakeholder meeting will be used to calibrate the Inclusive Practices Toolkit to the needs of families in Arkansas.
