## GRANTS AND DATA MANAGEMENT ADVISORY COUNCIL UPDATE August 24, 2017

ADE Finance has posted allocations for FY18 for 611 and 619 for special education programs and reimbursing programs for costs incurred.

The special education finance office will continue to approve budgets and payments to programs for IDEA eligible expenses.

The Grants & Data staff continues to provide technical assistance to District and Education Service Cooperative (ESC) personnel.

Catastrophic funding was finalized in June as \$11,000,000 was provided for 1304 students at 164 districts. Since total claims after offsets and reductions for non-allowed expenditures exceeded funds available, the final reimbursements had to be prorated to 36.818%.

The fourth quarter residential reimbursement payment of \$3,821,754.26 was made in June. The fourth quarter reimbursement rate was increased from \$60 per day to \$83.78 (an increase of \$23.78) per day for fourth quarter days only. The rate will go back to \$60 per day for 2017-18.

Total ARMAC payments for 2016-17 to 266 distircts and education service coorperatives was \$19,791,953.64

Reimbursed just over \$109.554 million Title VI-B 2015-16 expenditures and 16-17 expenditures to districts in 2016-17 for expenditures through 6-30-17.

Reimbursed Title VI-B Section 619 Preschool 2016-17 payments of over \$5.718 million to 45 school districts and ESC for the FY17 school year.

Grants & Data continues to make monthly/periodic payments to district/co-ops/agencies for Title VI-B, Sp Ed Preschool, ARMAC, Medicaid match payments, Area Service Grants, and state appropriated programs--JDC, Residential, Easter Seals, HDC, DYS-JTC, etc,
