#### **DUE PROCESS HEARING ISSUES**

#### H-18-29

Failure to comply with provisions set forth in Part B of the Individuals with Disabilities Education Act (IDEA). Specifically by failing to provide a free appropriate public education. (S)

- 1. That the District failed to provide the Student with FAPE by not implementing the Student's IEP, specifically
  - A. by failing to provide services as documented in the IEP, which states that the occupational therapist would work with the education team to provide specific OT-related practices in the academic setting (NS)
  - B. by not providing a 1:1 aide, as documented; and (NS)
- 2. That the District failed to provide FAPE by not considering the concerns of the Complainant (NS)

#### C-18-25

1. That the district failed to implement child find requirements (S)

- 2. That the District failed to implement the Student's IEP as written (NS)
- 3. That the District held conferences without all required IEP team members (S)
- 4. That the District changed the Student's placement without informing the parents or holding a conference with the required IEP team members (S)

#### C-18-26

- 1. That the District failed to provide FAPE by not considering the strengths of the child for enhancing the child's education in development and implementation of the child's IEP (S)
- 2. That the District failed to provide FAPE by not implementing the Student's IEP as written, specifically in the areas of:
  - A. provision of speech therapy and occupational therapy (S)
  - B. providing periodic reports on progress toward annual goals (NS)

#### C-18-27

- 1. That the District failed to provide the Student with FAPE by not providing services comparable to those described in the Student's IEP from the previous public agency until adopting the previous IEP or developing and implementing a new IEP (S)
- 2. That the District failed to provide FAPE by not implementing the Student's (new) IEP as written, specifically in the areas of:
  - A. provision of speech and occupational therapy (S)
