The annual application pertains to the money the state received from the federal government for the education of students with disabilities. The proposed budget was discussed, and Council Members provided input. Chairperson Walker

indicated that in her observation, at the local level, monitoring has lead to improved program effectiveness and IEPs are better as a result of that process.

Presentation on Building the Foundations: Early Childhood Special Education Birth to Five:

Ms. Danita Pitts, Administrator for Early Childhood Special Education B-5, gave an overview of Part B and Part C of the Individuals with Disabilities Education Act, including federal requirements for both programs. For each requirement, recent Annual Performance Indicator data was covered to provide an overview of the measurement. Feedback was sought from the Council.

The transition indicator was discussed specifically regarding exit from Part C to Part B. Feedback was obtained to gain perspective on why discrepancies might be happening with the data and ways to improve and align transition supports moving forward.
