Failure to comply with provisions set forth in Part B of the Individuals with Disabilities Education Act (IDEA). Specifically, by failing to provide a free appropriate public education (FAPE) (NS - No C/A)

Failure to comply with provisions set forth in Part B of the Individuals with Disabilities Education Act (IDEA). Specifically, by failing to provide a free appropriate public education (FAPE) by failing to comprehensively reevaluate Student, a well as failing to provide IEPs reasonably calculated to enable Student to make progress appropriate in light of Student's specific circumstances. Request of an order changing the placement of the Student to an appropriate interim educational setting for not more than forty-five (45) school days (filed by District). (S)
