**COMPLAINT INVESTIGATION ISSUES**  
**(9)**

**C-25-05**

1. that the District failed to develop and implement an Individualized Education Program (IEP) for the Student that is reasonably calculated to allow for meaningful educational benefit, specifically, that the District failed to develop and implement the accommodations to support the behaviors of the Student, resulting in the Student being disciplined for disability-based behaviors. (S)
2. that the District denied meaningful Parent participation by predetermining placement outside of the IEP team meeting. (NS)

**C-26-06**

1. that the District failed to develop and implement an Individualized Education Program (IEP) for the Student that is reasonably calculated to allow for meaningful educational benefit, specifically, that the District failed to implement the services in the IEP. (S)

**C-26-07**

1. that the District failed to develop and implement an Individualized Education Program (IEP) for the Student that is reasonably calculated to allow for meaningful educational benefit [8.01.1], specifically that the District failed to implement accommodations listed in the IEP and that the IEP team failed to address Student absences due to medical issues. (NS)

**C-26-08**

1. that the District failed to develop and implement an Individualized Education Program (IEP) for the Student that is reasonably calculated to allow for meaningful educational benefit, specifically, that the District failed to develop and implement an IEP to support the behaviors of the Student, resulting in the Student being disciplined for disability-based behaviors. (NS)
2. that the District failed to provide meaningful parental participation by not allowing observation of the video footage of the incident. (NS)

**C-26-09**

1. that the District failed to comply with special education laws and regulations governing the provision of a free appropriate public education (FAPE). Specifically, the complaint alleges the following violation of the ADE Special Education and Related Services Procedural Requirements and Program Standards:
  - a. that the District failed to meet its child find obligation to identify, locate, and evaluate the Student who may need special education and related services. (S)

**C-26-12**

1. that the District failed to develop and implement an Individualized Education Program (IEP) for the Student that is reasonably calculated to allow for meaningful educational progress, specifically that the District failed to provide the services listed in the IEP. (NS)
2. that the District denied meaningful Parent participation by including people in the IEP meeting that were not included in the Notice of Conference. (NS)
3. that the District impeded the Parent's opportunity to participate in the decision making process, specifically by not communicating with the Parent. (NS)

**C-26-16**

1. that the District failed to develop and implement an Individualized Education Program (IEP) for the Student that is reasonably calculated to allow for meaningful educational progress [8.01.01], specifically:
  - a. that the District failed to develop and implement an IEP to support the behaviors of the Student, resulting in the Student being disciplined for disability-based behaviors, (S)
  - b. that the District failed to conduct a Functional Behavior Assessment (FBA) and develop a Behavior Intervention Plan (BIP), (NS)
  - c. that the District failed to reconvene the IEP team after new medical information was provided.(NS)
2. that the District failed to provide meaningful parental participation by not providing access to educational records. (NS)

**C-26-17**

1. that the District failed to develop and implement an Individualized Education Program (IEP) for the Student that is reasonably calculated to allow for meaningful educational progress, specifically, that the District failed to implement the services in the IEP. (S)

**C-26-18**

1. that the District failed to meet its child find obligation to identify, locate, and evaluate the Students who may need special education and related services. (S)
