## C-17-01

- 1. That the District failed to provide the Student with a free appropriate public education by not providing services to address all of the Student's identified special education needs (S)
- 2. That the District failed to implement the Student's IEP, specifically by not providing the modifications listed in the IEP (S)
- 3. That the District failed to revise the Student's annual goals in the general education curriculum (S)

## C-17-02

- 1. That the Educational Co-operative Service failed to adhere to transition guidelines established between the Early Childhood Educational Program and the LEA as set forth by the ADE in Section 21 (NS)
- 2. That the Educational Service Co-operative failed to obtain informed parental consent before conducting a re-evaluation of a child with a disability (NS)
- 3. That the Educational Service Co-operative Service failed to adhere to the ADE Special Education and Related Services Procedural requirements for re-evaluation by conducting more than one evaluation in a years time without parental agreement (NS)
- 4. That the Educational Co-operative Service failed to adhere to the ADE Special Education and Related Services procedurals requirements by not performing classroom observations before dismissing a student from speech therapy (NS)
- 5. That the Educational Service Co-operative failed to adhere to the ADE Special Education and Related Services Procedural requirements by not providing timely progress reports by related service providers (S)
