CAYSI

- CAYSI has visited with 11 students during the month of September visiting schools and homes to support the students.
- CAYSI hosted a panel discussion in collaboration with Helen Keller National Center (HKNC), Arkansas Rehabilitation Services (ARS), and Division of Services for the Blind (DSB) to provide greater understanding of adult services for those who are DeafBlind.
- Four families are participating with the Positive Eye Family Storytime Event Series. This event series is designed for students with deafblindness and promotes literacy skills. This was in collaboration with Gwyn McCormack, founder of Positive Eye, and other state DB projects across the country.
- An online family support group called CAYSI Casual Connections was hosted to assist gathering a needs assessment for families to guide future work.
- CAYSI is working closely with our Infant Hearing Program to discover best practice to receive referrals during the newborn hearing screening process.

 - The majority of AR Apps for Special Education have been approved.
 - Preliminary Budgets were pulled on 10/14 and review has begun.
- Increase to the High-Cost Occurrence fund for 24-25 of \$500,000
 - High-Cost opens in December and closes in March.
- Completed summer trainings, Navigating Special Education Obligations, in September.
- Started Timeframe 1 of Fiscal Monitoring
- In-depth work to align IDEA Part C fiscal with IDEA Part B and ADE.

New Significant Disproportionality Calculator Application

- Spent last two years getting this application developed with the help of some very skilled graduate assistants from the Information Quality Program.
- Once we have the data from child count and discipline we can run the calculator and have it upload to the data warehouse within minutes.
- Once the risk ratios are loaded we can bring up a data view which informs us which LEAs are required to set aside funds the following year.
