Arkansas Plan and Timeline for Transition to the Unified English Braille Code

The Arkansas Unified English Braille (UEB) Transition Committee recommends the use of Nemeth Code as the default for math and science notation, within the context of UEB. The committee recommends UEB math and science notation as an option based on student need, as determined by the Individualized Education Program (IEP) team. The committee also recommends that guidance on selecting the appropriate math and science notation be provided.

The Arkansas Region of the National Braille Challenge offered statewide contests in UEB for grades 4th and under.		
Stakeholders were surveyed regarding instruction in UEB versus UEB/Nemeth Code for math and technical subjects.
